REQUIREMENTS TO OPERATE GOLF CART / UTV ON ROANOKE'S STREETS.

1. CURRENT REGISTRATION WITH GOLF CART / UTV
2. VALID DRIVER'S LICENSE
3. FINANCIAL PROOF WITH GOLF CART / UTV
4. TIME ½ HOUR BEFORE SUNRISE AND ½ HOURS AFTER SUNSET
5. SLOW MOVING SIGN REFLECTIVE ON BACK OF CART / UTV
6. NO SIDE WALKS
7. IF OPERATOR IS LESS THAN 18 YEARS OF AGE NO MORE THAN TWO (2) ADDITIONAL PERSON UNDER THE AGE OF 18 ARE ALLOWED
8. CAN ONLY OPERATE ON TOWN STREETS, CAN ONLY CROSS U.S. 24 (**CAN NOT OPERATE ON U.S. 24**)
9. DATE OF OPERATION: MARCH 1ST to NOVEMBER 30th of THE YEAR
10. NO TRAILERS / CARTS PULLED BEHIND GOLF CART / UTV AT ANY TIME (NO TOWING)
11. SPEED LIMIT 30 MPH
12. NO ONE UNDER THE AGE OF 2 YEARS OLD ALLOWED RIDE IN GOLF CART/ UTV AT ANY TIME
13. ANY AND ALL OPERATORS AND RIDERS OF A UTV WHO ARE UNDER THE AGE OF 18 YEARS SHALL WEAR HELMETS AT ALL TIMES WHILE SAID UTV IS IN OPERATION. **IC 9-18.1-14-11 Helmet requirements for off-road vehicle operators. IC 14-16-1-33 Operation of an off-road vehicle in violation of helmet requirement**

74.09 TRAFFIC LAWS AND ORDINANCES.

The operator of the golf cart or UTV on a town street shall comply with all then effective traffic laws, ordinances, rules, and regulations adopted by the state and the town.

74.99 PENALTY

- A. Failure to comply with this chapter will result in fines and penalties as follows: first offense: \$25 fine; second offense: \$50 fine; and each additional offense: \$100 fine.
- B. An offence is defined as each separate violation of this chapter which occurs while operating a golf cart or UTV.
- C. The golf cart or UTV may be impounded by law enforcement officer. In the event of impounding, the golf cart or UTV shall not be released until the basis of the violation has been corrected and all towing and impoundment fees incurred as a result of the impoundment of the golf cart or UTV have been paid by the owner or operator of the golf cart or UTV.
